

State of the Sector reports baseline research so

Following our Cornerstone co-design session in September 2021 looking at data about the sector in London and attended by 16 CVSs / infrastructure organisations (see round-up at <u>https://datawise.london/resources/data-about-civil-society</u>), we included a budget to continue this work in our Cornerstone Round 2 full proposal.

We have since been awarded new funding and Datawise London phase 2 officially started in July 2022 - see further info here <u>https://datawise.london/about</u>.

In the co-design session, standardising elements of State of the Sector data collection, analysis and sharing, was suggested as a 'small collective step' we could take together to realise better outcomes.

But to start with, we need to find out more about which borough CVS's have done State of the Sector reports* recently, what's been the drivers and challenges, what resource is involved and who's got one coming up and would be keen to be part of a pilot working together to look at standardising a set of questions and trialling new ways of publishing the data. **Hence this survey!**
