- Typically fund 300 organisations at any time

Our communications aims

Good homes & neighbourhoods

Funding for advocacy work on housing issues and housing legal advice at a specialist level.



Better work

Progression routes out of low-paid work; specialist employment legal advice; advocacy on employment issues and capacity-building.



Decent living standards

Advocacy on welfare reform, the cost of living, and public attitudes to poverty. Representation and strategic legal action in social welfare law.



Shared wealth

Advocacy work on understanding and reducing income and wealth inequality in London.

Pathways to settlement

Specialist immigration legal advice and advocacy work on the immigration system and pathways to citizenship.

Connected communities


Small grants for small groups with an annual income under £100,000. Funding for campaigning, advice and community activities in isolated areas.



Stronger voices

Funding for second-tier and specialist organisations to help other organisations develop their skills.

- 73% of grants in 2021 went to organisations with an annual income under £600k
- Includes 29% to the very smallest, under £100k
- 9% of grants went to organisations with income over £1.85m, which includes grants to universities



Stronger voices

What we want to fund

Work that enhances the capacity of civil society to influence policy and decision making

Who can apply?

- Second tier and specialist organisations
 - proposing to improve the skills and practice of smaller or less experienced organisations
- Civil Society organisations
 - working alongside groups of individuals to increase their collective voice in campaigns to tackle the root causes of poverty

What type of work?

•Campaigning: community organising and advocating for specific policy changes

•Strategic communications: improving the framing of narratives and messages to influence public attitudes •Gathering evidence about poverty and inequality: collecting qualitative and/or quantitative data about the impact of poverty and inequality on different communities

•Voice: increasing the involvement and skills of people with first-hand experience of poverty and inequality in campaigning and leadership of organisations and movements

Connected communities

Who is for?

Groups with incomes less than £300,000 per year

Gives priority to:

•Organisations that serve and are led by Black and minoritised groups

•Organisations that serve and are led by Deaf and Disabled people

What type of work?

•Campaigning: We will fund groups of people with direct experience of the issues to speak out for themselves and campaign for solutions to issues that impact on communities affected by poverty and inequality.

•Advice work: We will fund groups of people with direct experience of the issues to speak out for themselves and campaign for solutions to issues that impact on communities affected by poverty and inequality.





Poverty rates almost double when housing costs are accounted for


Poverty rates by region (2019/20)

Housing costs as proportion of net income for households in poverty (2019/20)





Proportion of Londoners in poverty in families with and without disabled persons (2009/10, 2014/15, and 2019/2020)







The chart above summarises the boroughs' indicators across each of our themes, center represents worse performance, outer rings better




Brent ratings across key indicators

Advice for Renters - case studies

- Two case studies from residents that they have supported who lost their jobs during the pandemic and are unable to return to work.
- One Brent resident, a 64-year-old, has only £200 left a month once deductions have been made and rent has been paid. Half of this then goes on electricity and gas, leaving her with very little to live on, and leading her into heavy debt.
- Single mother MN lost her job during the coronavirus pandemic due to health. After she applied for Universal Credit, her entire payment was sent to her landlord to pay for rent and rent arrears. This left her with no income to feed her family or heat her home, which already had a severe damp and mould problem, worsening her underlying respiratory problems.




Our new report comparing poverty rates across London boroughs showed that more than half of people in poverty in London are from working families.



Minimum London Weighting

Key findings

- Minimum London Weighting needed is £9,600 in inner London
- 50% how much more people need to achieve a decent living in standard in London
- 1980s the last time we had a coherent system for setting a London Weighting

Key findings

- 40% of those interviewed did not know about basis rights like sick pay or Christmas pay
- £8.77 the average hourly pay, well below the national minium wage.
 Some earned as little as £3 an hor
- 45% of those interviewed experienced poor condition like missing wages or discrimination

Many employers use widespread lack of knowledge of rights and English to their advantage, setting the floor & ceiling for wages

Story: Residents in a tower block in Croydon, previously named "Britain's worst building", say findings of a Coroner's court in Rochdale over the cause of death of a toddler need to lead to profound changes in the way social housing stock is managed. Findings showed prolonged exposure to mould was the primary cause of death of the infant. It comes as official figures show over 50,000 council households in the capital have issues with damp and mould, as we approach winter against a backdrop of soaring energy bills and the cost-of-living crisis.
